Please read the following statements carefully, as they construe conditions for employment at NPG, Inc. a.k.a.: Nelson Paving & Sealing (hereinafter, the "Company"),.

I understand and agree that if I am employed by the Company, I shall be employed on an at-will basis. As an at-will employee, I understand and agree that either the Company or I can terminate our employment relationship at any time for any reason, with or without advance notice, and with or without cause. I understand and agree that, although over the course of my employment, other terms and conditions of my employment may change, the at-will relationship of my employment will not change. I understand that no one other than the President of the Company may enter into any agreement with me contrary to the foregoing and that any such contrary agreement must be in writing signed by the President and me.

The information that I have provided in this Employment Application is accurate and true to the best of my knowledge. I understand that any misrepresentation or omission of a fact on my application, resume or during the interview or hiring process may result in the refusal of employment or, if employed, immediate termination of employment.

The persons, schools, current and former employers and other organizations or employers named in this application, or any reference list provided by me, are requested and authorized by me to verify the information I have provided, to fully and thoroughly provide any information they have regarding me, whether or not it is in their records, and to provide the Company with information that may be requested by the Company to arrive at an employment decision. I agree that a photocopy of this authorization will be acceptable and have the same authority as the original. I agree that neither the Company nor the providers of information will be violating my right to privacy in any manner. I hereby waive, release and hold harmless all persons, schools, current and prior employers and other organizations from any liability arising from the disclosure of any of the above information, whether in writing or orally, and further waive, release and hold harmless the Company from any liability arising from reliance on the aforementioned information or the use, publication, or retention of such information within the context of its applicant review procedures.

I understand that in connection with my prospective and/or current employment with the Company, a Motor Vehicle Report (MVR) will be obtained by the Company or the Company's Insurance carrier and/or insurance broker to ascertain my driving history to determine my driving privileges in regards to the Company's vehicles.
